# 6.1 PROGRAMME UPDATE - LAND TRANSPORT ROAD RECOVERY

#### **PURPOSE**

To provide an update on the Land Transport Road Recovery Programme and the work undertaken during May 2025.

That the Transport Committee receives the Key Programme Status Report – Land Transport Road Recovery update.

The report was introduced by Rebecca England and Mark Kinvig highlighting:

- Significant progress since April. Reconstruction wrapping up on most sites.
- Three sites (Burnside Bridge, Site on Pourere Road, Site on Pōrangahau Road) programmed for next financial year due to various reasons.
- Community engagement on sites like Burnside Bridge is ongoing, and updates will be provided later in the year.

- **Phase Four** Recovery Programme: Current phase confirmed as Phase Four; project and site details to be shared in an upcoming workshop.
- Programme Risk & Maintenance Budget: Responsibility for site safety shifting to the maintenance budget; risk slightly reduced but remains high. More detail on budget impact to follow.
- 89% FAR Confirmed: Funding confirmation reduces delivery pressure, allowing better use of construction season; some projects may extend into next financial year.
- **Community Engagement Bridges:** Engagement for Wilson Cutting, Todd Road, and Burnside Bridge planned for July, with a workshop in August and paper in September.
- **Burnside Bridge Risk:** Ongoing risk assessment includes learning from other councils; further details to be presented in a future workshop.

# 6.2 FLETCHERS CROSSING STAGE 3 - LEVEL OF PROVISION

# **PURPOSE**

To present the repair options considered for stage 3 of the Land Transport Recovery Fletchers Crossing project and seek a decision on levels of resilience.
